DOT 2 <i>Delivery within a time frame of 2 hours (e.g. between 12.00 PM and 02.00 PM)</i> 	09.00 AM - 03.00 PM	Book online* or contact your freight terminal no later than 04.00 PM (Mon-Thu) and 03.00 PM (Fri). Add the time frame to the consignment note (e.g. Delivery between 12.00 PM and 02.00 PM). Stick a DOT-label on to the shipment.	Find the current price under "Rates and surcharges" in "Your Consignment" at www.fragt.dk
DOT 3 <i>Delivery at a given time +/- 15 minutes</i> 	06.00 AM - 05.00 PM	Book online* or contact your freight terminal no later than 04.00 PM (Mon-Thu) and 03.00 PM (Fri). Add the agreed time to the consignment note. Stick a DOT-label on to the shipment.	Find the current price under "Rates and surcharges" in "Your Consignment" at www.fragt.dk
DOT 4 <i>Evening delivery at a given time +/- 15 minutes</i> 	05.00 PM - 10.00 PM	Only by prior arrangement, contact your nearest freight terminal no later than 04.00 PM (Mon-Thu) and 03.00 PM (Fri). However, the earliest delivery time is the following evening. Add the agreed time to the consignment note. Stick a DOT-label on to the shipment. In general concerning all DOT-products

DOT deliveries cannot be booked to addresses on islands without bridges to mainland as well as Schleswig-Holstein.

*) DOT-bookings must happen in WebFragt, Consignor or another EDI.

By applying the DOT-concept, the usual Danske Fragtmænd concept of day-to-day delivery (cf. General conditions for transport § 1.4) is not applicable and the CMR Convention's rules about an agreed time limit are applied. Cf. CMR-convention § 33, payment for DOT-time delivery is not to be regarded as a fee. Compensation for special interest in the case of loss or damage, or of the agreed time-limit being exceeded requires a prior explicit and individual agreement in addition to the DOT-agreement.
